Fort Wayne Research


Members planning to attend the annual conference in Fort Wayne in June 1998 should be aware that one of the resources of the Allen County Public Library in Fort Wayne is its collection of over 4,000 titles, of genealogical and local history periodicals. If a researcher has learned of an article in a genealogical magazine and has had difficulty in locating that particular magazine, there is a very good chance that the library has it.

The library annually publishes its *Periodical Source Index*, usually referred to as PERSI. These books place in a single index the articles in the many periodicals that the genealogy department of the library has received during that year. The articles are indexed under family surnames, subjects, and localities.

Many libraries around the country have a copy of PERSI. Anyone able to locate this index could determine, at home, the articles that they wish to find when they visit Fort Wayne.

Many of the periodicals are bound and are on open shelves. Call slips for periodicals in the closed stacks require the name of author, title of article, the specified four letter symbol identifying the publication, and the volume number.

In Memory

Sarah Blair Dougherty

Sarah Blair Dougherty (#550) passed away on Friday, 20 June 1997, in Austin, Texas. She was born 23 April 1914 in Belton, Bell County, Texas. Her father, Judge Mallory B. Blair, served as Bell County Judge (1916-1920), 27th Judicial District Judge (1920-23), and Associate Justice of the Third Court of Civil Appeals at Austin in 1922.

Sarah graduated from the University of Texas in 1934 with a degree in English Literature. She was a member of Kappa Kappa Gamma Sorority and in spring 1934 was elected Sweetheart of the University. In the summer of 1934 she attended the University of Southern California at Los Angeles, where she took voice lessons and music courses and on two occasions was given bit parts in Hollywood movies. She obtained a Master of Arts in Education from the University of Texas, and was a teacher and counselor in the Austin public school system for many years, retiring in 1981. She was a member of the Austin Retired Teachers Association, the Junior League of Austin, and the University Presbyterian Church. She had a beautiful voice, and sang in the University Methodist Church choir for more than 25 years and at many weddings.

In 1937 Sarah married Gibson R. Randle. A son, Mallory Blair Randle, was born in 1940, and they adopted a daughter, Sally Randle in 1955. They were divorced in 1977. In 1981 Sarah married J. Chrys Dougherty IV of Austin. She is survived by her sister, Dawn Blair Woodward, Brookesmith, Texas, and by four grandchildren, three greatgrandchildren, two step-grandchildren and several nieces and nephews.

Sarah is descended from James King and Elizabeth (Bailey) Blair. She loved working on her genealogy and will be greatly missed by the Blair Society. We are happy to report that her husband, J. Chrys Dougherty, wishes to continue this work and Sarah's BSGR membership number has been assigned to him.

Robert K. Blair

Robert K. Blair (#375) passed away on Monday, 28 July 1997, at his residence in Westbend, Wisconsin. He was born 21 March 1921 in Milwaukee to the late Ralph and Hazel (Morris) Blair. He served with the United States Merchant Marines in both the Atlantic and Pacific theaters in World War II. For 36 years he was employed as a manufacturing engineer at the Square D Company in Milwaukee, retiring in 1983. Upon retirement he moved to Arkansas, then returned to West Bend in 1992.

In 1950 he married Joyce Shipley in Milwaukee. She passed away on 22 January 1973. He then married Ruth Briganste-Finkler on 15 November 1975 in Jackson, Wisconsin. He was a member of the Gallups Island Alumni Society, American Legion Post 333, Lions Club, and the Washington County Historical Society. He is survived by his wife, Ruth; 4 children, Barbara Blair of Slinger, Wisconsin, Ralph Blair of West Bend, Brian Blair of Hartford, Wisconsin, and Elizabeth Blair of Slinger; 2 stepdaughters, Jane Towler of Kewaskum, Wisconsin and Mary Ann Velnetske of Cedarburg, Wiisconsin; a son-in-law, Michael Towler of West Bend; 2 sisters, Elizabeth Kirchhoff of Lakeland, Florida, and Patricia Blair of Milwaukee; 10 grandchildren, a great-grandchild, and many other friends and relatives. Robert's earliest known Blair ancestors are Robert and Isabelle (Rankin) Blair. He was a dedicated member of the Blair Society and will be greatly missed.

At the age of 18 (1839) Robert Downey Blair (R. Downey as he was called) joined the Cumberland Presbyterian Church. He studied under the guidance of Rev. David Robinson and Rev. Laban Jones and was ordained in 1848.

In 1852 he became permanent pastor of three churches in Jefferson County, Kentucky at Bethlehem, Jeffersontown and Pleasant Grove. He bought a small farm near the Pleasant Grove church where he lived with his family for forty years. The salary of a pastor was not much in those days. Rev. Blair had to supplement his income by teaching school and farming. He truly enjoyed teaching and spent many hours tutoring after regular school hours.

In 1868, after sixteen years at the three churches, he decided he needed a change. From feeble struggling churches he had built them into self-supporting, thriving churches and was ready for a new challenge. He therefore enlisted as a missionary for the Presbyterian church and went into the mountains in Kentucky. He went to the most primitive places, where there were no schools or churches, and preached and taught Sunday school wherever he could, sometimes in one-room homes. The children were a special joy to him and he was very successful with them.

After several very productive and fulfilling years he was forced to resign and return home. His wife, Lucinda (Holliday) was in poor health and he needed to look after his large family. Within a short time he was asked to

return to his three former churches. It was a special joy to minister to the children and grandchildren of the families he had ministered to as a young man.

Rev. Blair married Lucinda Holloway, daughter of Major and Sarah (Whittaker) Holloway in 1847. They were the parents of five sons, the eldest a physician and ruling elder in his church, the second a lawyer, and the three youngest ministers in the Cumberland Presbyterian Church. Their four daughters married into good Christian families. Sarah married John Thomas Bates, Ann Elizabeth married Moses F. Johnson, Rachel married Dr. Henry Clay Ireland, Lucinda married Edwin Hansbrough. All lived in Jefferson County, Kentucky. Rev. William ministered in Missouri, George and James in Oregon and Washington. Dr. Benjamin settled in Lebanon, Ohio.

After the death of his wife in 1890, Rev. Blair went to visit his son Rev. George Blair, pastor of a church in Eugene, Oregon. He remained there for a year and then located in Missouri where he met and married Miss Ella Thompson. They were the parents of one daughter, Elizabeth E. Rev. R. Downey Blair passed away on May 15, 1897 in Corinth, Kansas where he had moved to become pastor of a country congregation.

MARTHA BLAIR AND MARY BLAIR - WIVES OF JOHN PAXTON

An Hypothesis By Arthur B. Broddus, BSGR Mem. #491

The object of this note is to present an hypothesis which best explains the information and speculation concerning the wife or wives of John Paxton who was born in Ulster about 1716, emigrated to Pennsylvania about 1735, and then moved to what was later Rockbridge County, Virginia, about 1746.

Martha Blair is named as his wife in early sources while his will names his wife Mary. Oscar Lyle published in 1912 a Lyle genealogy which mentions Martha Blair and her niece Mary Blair. On pages 327 and 328 are discussed the nine children of Samuel Blair of Ulster, b. 1667, d. 20 Mar 1754. "Esther Blair, b. ab't 1712, m. 1731, Matthew Lyle and went to Rockbridge area, Virginia;..."James Blair m._ daughter Mary went to Virginia with that Blair and is the Mary Blair mentioned as equal heir in the will of John Houston in Rockbridge Co., Va., of date April 24th. 1748"... "Mary Blair m. David Lyle, a son of Robert Lyle, m. Annie Locke; Emigrated. Probably went to South Carolina." "John Blair. Probably went to Virginia." "Martha Blair ... Went to Virginia and m., Capt. John Paxton."

Thus we have evidence that Martha Blair married John Paxton, that her niece Mary was in Rockbridge, that her sister Esther was in Rockbridge and that two brothers, James and John, were probably in Virginia.

The argument that Mary might be just another form of Martha does not make sense when one realizes that Martha had a sister named Mary. Also, the usual nicknames for Martha are Marty, Mat, Mattie, Patsy or Patty, while the usual nicknames for Mary are Molly and Polly. John's wife has been called Mary, Polly, Martha, Patsy, and Mattie².

Both Martha Blair and Mary Blair are named as wives of a John Paxton by Oren F. Morton in his *History of Rockbridge County, Virginia*. Under "Miscellaneous Data" on page 518: "2. John - son of 1., b. 1716, d. 1787 [?]- m. Mary Blair, 1742c." Then on page 520 is listed: "40. John - m. Martha Blair, 1730c." Under Mary and John were listed all the children. Thus some people were reporting that a John Paxton had married a Martha Blair. 1742 seems to be the correct date for the first marriage since the first son was born in 1743. 1730 is early; but the important point is that a Martha Blair married a John Paxton, thus supporting the hypothesis.

The next mention of Martha Blair as John Paxton's wife is by William Marshall Greene in Historic Families of Kentucky, pages 107-109. This Greene was a son of Mary Keith Marshall and Judge John Greene. Mary Keith Marshall had previously been married to James Alexander Paxton, father of William McClung Paxton who published The Paxtons: We Are One! Both these commentators initially named John's wife as Martha.

Previously in 1885, W. M. Paxton had named Martha as John's wife in The Marshall Family.6 Here in 1885, W. M. Paxton, a grandson of James Paxton, son of John Paxton, mentions Martha as the wife. At the time, W. M. Paxton had little knowledge of the Paxton genealogy. His grandfather James had been killed in a hunting accident leaving only one child who shortly went to Kentucky with his mother who had married a Moore, W. M.'s father died when he was six. Even in 1897 in his Annals of Platte County, Missouri, W. M. listed John's wife as Martha. Later, W. M. Paxton researched and published The Paxtons: We Are One! mentioned above. On page 44 he lists Mary Blair: "No. 6 JOHN PAXTON, son of John Paxton and Elizabeth Alexander, b. 1716, d. Feb. 13, 1787, married in Lancaster County, Pa., about 1742, Mary Blair, b. 1726, d. Aug. 12, 1821. She was a daughter of Rev. Robert Blair." By this time I suggest W. M. Paxton had discovered John Paxton's will of 1787 and the deed of Mary Blair Paxton in 1810. In a chart on page 33 of his work: "John Paxton 1716-1787, Mary Blair 1726-1821." How do these dates fit the family of John Paxton and his wife?

Neither in the Pennsylvania area where the Paxtons initially settled nor in the Rockbridge County, Virginia area have I found a "Rev. Robert Blair" who could be the father of Mary Blair who married a John Paxton.

First, let us consider John Houston who mentioned Mary Blair in his will dated 24 April 1748/1749 and probated May 15, 1755. Although the will does not name the wife, she is named in the bond where Margaret Houston, John Moore, the other executor, Matthew Lockage and Matthew Lyle sign. John left Mary Blair a share with the rest of his children. John Houston lived near New Providence Church, established in 1746, and thus about fifteen miles from Lexington where John Paxton lived.

If Martha Blair was born in 1726, we then can estimate the birth of her niece Mary Blair about 1736 to 1741. Thus in the mid 1750s she was young, available, and known to the widowed John Paxton when he needed a wife to manage his home and care for his young children.

About 1909 statements, that if true would disprove this hypothesis, were made in the Genealogical File of Dr.

"John Blair was the Eleanor M. Hiestand-Moore.9 fourth son of Samuel Blair of Ballyvallough ... and his wife Martha C. Lyle. There were eight children: Esther who married Matthew Lyle in September 1731; Mary who married David Lyle 27 December 1735; Patrick who married Margaret McCullough; William who married Mary Rea; Martha who went to Virginia and there married a man named Houston; John your ancestor [?]; James who also went to Virginia (not established. E.M.H. Moore) and Nancy who married David Robinson. "Note by E.M.H. Moore: This enumeration seems to be correct as to the number and names of the children but otherwise it is very inaccurate because (1) Martha Blair married Capt. John Paxton; James Blair is missing and it may be he was the James Blair who was killed by the Indians at Fort McCord in 1756 in the neighborhood of the original Blair settlement in what was then Cumberland County: Mary Blair, daughter of this missing James married John Houston of Rockbridge County., Virginia. (See the Paxton-Houston Genealogy compiled by Hon. W. A. Houston of Rockbridge County, Virginia); ... Of the children of Samuel Blair and Martha Campbell Lyle, two remained in Ireland, William who married Mary Rea and Nancy who married David Robinson.)"

I disagree with Mrs. Moore's conclusion that Mary Blair married John Houston. Apparently she bases that finding on the Paxton-Houston Genealogy compiled by Hon. W. H. Houston of Rockbridge. I have been unable to find such a work by any W. H. Houston. However, a Judge W. P. Houston of Lexington, Rockbridge County, Virginia did compile a 16-page work entitled "The Rockbridge County, Virginia, Paxtons." On page 4, "JOHN PAXTON, the eldest son of the widow, was born in Ireland in 1715. There, or after he came to America, he married Mary Blair..."

"John Paxton died February 13th, 1787, and is buried in the old Timber Ridge graveyard ...

"His widow survived him many years, and died August 1821, aged over 96 years."

The point of the foregoing is to negate the suggestion that Mary Blair married a Houston. And there is further proof that she did not marry a Houston.

In 1882, the Reverend Samuel Rutherford Houston, D.D., wrote a Houston genealogy. He starts with the first Houston in Rockbridge County, the John Houston above, whose will mentioned Mary Blair. Among his sources are a mss. left by Rev. Samuel Houston, who died in Rockbridge County in 1839 at eighty-one years of age. He was a son of the John Houston who mentioned Mary Blair in his will. Another son and source was Matthew Houston who died in Rockbridge County in 1847 in his eighty-fifth year. No Houston is mentioned as marrying a Mary Blair.

As mentioned, John Paxton's will names his wife Mary. What is very pertinent is that all the writers and genealogists then go on to say his wife was Mary Blair, not an unknown with another maiden name. And the Lyle book which mentions Martha Blair was not published until 1912. One can say that Oscar Lyle worked down through the Lyle and Blair genealogy until he came to Martha Blair. W. P. Houston lived in Rockbridge and checked the deeds and wills there as well as personal traditions. He decided the wife was Mary Blair. I think they are both correct.

W. M. Paxton who wrote *The Paxtons: We are One*, was a lawyer in Platte City, Missouri, when he wrote *The Marshall Family* in 1885 and the *Annals of Platte County* in 1897. He had not done much research on the Paxtons and named Martha as the wife of John Paxton;

he had lost contact with Rockbridge County. His father, son of James Paxton, left Rockbridge as a young child; and his father died when W. M. Paxton was six years old. While doing research for his Paxton book, W. M. discovered John Paxton's will which named Mary, and became aware of the W. P. work. Thus he changed his mind and named Mary Blair as John's wife. I do not know where he obtained the information that Rev. Robert Blair was her father, but if Mary Blair was John Paxton's only wife then he married her about 1741 in Pennsylvania.

Two deeds possibly bear on the question of John Paxton's wives. A deed in 1768¹² from John Paxton to his son John has no wife's signature or waiver of dower. Then a deed in 1777¹³ names his wife Mary and she signs, but again there is no waiver of dower; maybe because the grantee was his son William. I think this is just sloppy legal work. There is another deed where John bought property without getting the wife's waiver of dower and that wife later sued for her dower. Let us see what dower rights did for Mary Blair Paxton.

In his will probated in 1767,15 John gives Mary, in place of dower, support for life from his home plantation. Support was to be kept up by his son James to whom he devised that home plantation. James, however, was killed in a hunting accident in 1788, leaving his widow Phoebe McClung Paxton and one son, James Alexander Paxton, born 13 September 1788. A few years later the widow remarried and moved to Kentucky. Conflicts arose about the payment of Mary's support and she was forced to file suit in Chancery. I have been unable to locate the court records but a deed in 1810 recites that Mary won the suit and in return for a considerable sum of money and annual support she waived her dower rights. The deed or agreement is signed by Mary and James Alexander Paxton. 16 This deed was witnessed by Andr. Alexander, Wm. Caruthers and James McDowell. Immediately preceding was the deed by James Alexander Paxton to James McDowell of all John Paxton's home plantation.17 And William Caruthers, whose brother was James, was a logical witness.

The 1810 census for Rockbridge shows William Caruthers living just ten doors away from his brother James Caruthers who had married Mary Blair Paxton's daughter, Hannah, on 24 January, 1793. In 1810 the census records indicate Mary was living with James Caruthers and Hannah. Hannah's estimated age was 40 to 45 while Mary's age is estimated at 65. James' census in 1810 shows living with him one female 26 to 45 years old and one over 65, very likely Hannah and Mary. The 1820 census of James shows two women

over 45, again very likely Hannah and Mary.¹⁹ Mary is said to have died August 21, 1821.²⁰ James Caruthers died in 1828.²¹ Thus, Hannah Caruthers as head of the household is listed in the 1830 census at age 60 to 70.²² There is no older woman who could be Mary. Hannah died in 1845.

The grave sites of the Paxtons bear some discussion. The grave of Elizabeth Alexander, widow of John Paxton, both emigrants from Ulster, is in the Paxton Cemetery, in Rockbridge County, three miles south of U.S. 60 on Route 608, just south of where Route 699 enters it. Also in that cemetery are all her sons except John. 23 W. M. Paxton in We Are One!, page 44.24 John Paxton and Mary Blair are: "Both buried at Timber Ridge Presbyterian Church. His epitaph, on a brown stone slab, lying in the garden of Mr. Brady, reads: "Here lies interred the body of John Paxton, who departed this life Feb. 13 1787, aged 71." On page 28 discussing Presbyterian Churches in Augusts (now Rockbridge) County: "The first [Presbyterian meeting house] at TIMBER RIDGE was built of logs, and was nine miles South [sic, he means North] of Lexington, and two miles from the present building."

Reverend Samuel Rutherford Houston in *The Houston Family*²⁵ states in discussing Robert Houston, son of John: "He lived on Timber Ridge, some five or six miles northeast of Lexington and owned the farm on which Timber Ridge Church is located. The first church called by this name was a log building, situated about two miles from the present stone house in the direction of New Providence Church. The building of stone was

erected in the year seventeen hundred and fifty-six (1756), and the Timber Ridge Church was organized in the same year." The New Providence church is north.

Judge William Paxton Houston in *The Rockbridge County, Virginia, Paxtons*²⁶ writes, "John Paxton died February 13th, 1787, and is buried in the Old Timber Ridge graveyard."

Muse Cemetery²⁷ is located about two miles north of Timber Ridge Cemetery on the northwest side of U.S. 11. This cemetery seems to fit the location given for the old Timber Ridge cemetery. Today the cemetery is a rectangular plot fenced inside a cow pasture in a hollow visible from the southbound highway lanes. Here is located the grave of John Paxton - a wide-coffin shaped horizontal slab with the inscription clear. Near John's slab is an almost identical slab, but much older, weathered, and with no inscription legible. Immediately one speculates that this might be the grave of Martha Blair Paxton and that she might have died in the 1750s. Why was John Paxton buried in this cemetery? Without some kind of connection he would logically have been buried in the newer Timber Ridge cemetery or with his mother and brothers. Another puzzle, I have not located Mary Blair Paxton's grave; I have not been able to conduct an exhaustive search.

In conclusion, the evidence to date supports the hypothesis that John Paxton married Martha Blair and then Mary Blair, Martha's niece. This I submit should be the genealogical record until conflicting evidence, if any, is found.

Corrected Genealogy of Wm. C. Blair (1826-1921) and Nancy Ann Powers (1822-1861) By Mary J. Powers, BSGR Mem. #240

Recently there have surfaced several versions of this couple's genealogy, each containing errors and misconceptions: that Wm. C.'s antecedents were Vermont Blairs; that his immigrant ancestor came to this country with John Paul Jones from Scotland; that Nancy's maiden name was Carder (and that the Carder's sprang from the "King Carter" of Virginia line, the spelling having been changed from "t" to "d"; that Wm. C.'s middle name was "Carey," which gave him Carey connections. Documentation does not support any of these claims.

WILLIAM C. BLAIR was born 29 Nov. 1826 in Kentucky, the son of Wm. Hamilton Blair and Phoebe Atkins. A copy of his parents' bible record gives the date of his birth and shows his middle name as "Cratary," although his direct descendants as well as his obituary give it as "Colin." Nowhere in family or public records is the name "Carey" used.

A pension application filed in 1879 by Phoebe against Wm. Hamilton Blair's War of 1812 service confirms their marriage in Fleming Co., Kentucky, and gives subsequent places of residence: Fleming and Nicholas counties; Logan Co., Ohio, and in 1851, Mahaska Co., Iowa, then to Monroe Co., Iowa. Wm. Hamilton's parents are said to be John Blair and Elizabeth Hamilton, he the son of Alexander Blair and Elizabeth Cochran of Pennsylvania. As William and Phoebe were married in the home of John's daughter Elizabeth and her husband, Daniel Scott, near Flemingsburg, Kentucky, i.e., Wm. H.'s sister's home, this supports this family connection. [Research on John is underway and will be the topic of a future paper.]

Wm. C. and Nancy Ann Powers were married in Logan Co., Ohio, 27 Aug 1846.1 She was the daughter of Jacob D. and Charity Carder Powers. Charity had a sister Nancy which one researcher had confused with Nancy Ann.2 In 1849 Nancy's brother, Wm. Carder Powers married Wm. C.'s sister, Emily Jane Blair in Champaign Co., Ohio, creating a double relationship between families. Wm. Carder and Emily, along with his parents, Jacob and Charity Powers and other Powers children migrated to Eddyville, Mahaska Co., Iowa in the fall of 1849; Wm. Hamilton and Phoebe and their younger children came there in 1851 taking up a land grant for his service in the War of 1812,4 and Wm. C. and Nancy followed in 1856, with four children, a fifth being born in Eddyville September 1856.

As for connections with John Paul Jones and King Carter of Va., neither are substantiated. John Paul first came to America in 1772/3 to visit his brother, William Paul at Fredericksburg, Virginia He stayed two years to administer Wm. Paul's estate, at this time taking the name "Jones" to honor a friend. This was some 20 years after Wm. C's ancestor, John Blair, was reportedly born in Lancaster Co., Pennsylvania.

There were Carders (with a "d") in Virginia in very early days: on a list of tithables in Lancaster Co. in 1670; James Carder appears on a deed from 1674 in old Rappahannock and New Kent counties; Capt. Andrew Carder sailed between Cowes, England and Virginia in 1692, and in 1705 and 1707 Uriah Carder and his wife Sarah baptized their daughter per the register of Christ Church in Middlesex Co. — all these spelled with a "d". In fact, one Peter Carder sailed with Sir Francis Drake and was marooned off the coast of South America. He survived several years a captive of cannibals before he was able to make his way back to England. He was brought before Elizabeth I, "where it pleased her to talk with me a long hour's space of my travails and wonderful

escape...and afterward bestowed Twenty-two angels [gold coins] on me." This in 1586.

PIONEER PASSES ON

BLAIR

William Colin BLAIR passed away Friday morning at the home of his son, Mr. James BLAIR, East Market Street, where he has lived for the preceding twenty years. Funeral services were held at the home Monday afternoon at two o'clock conducted by Rev. J. A. Riggs. Interment in the city cemetery. The pall bearers were six of the grandsons of deceased.

Mr. Blair was born in Kentucky November 29, 1826, moving to Ohio with his parents when a small boy. In 1846 he was married to Miss Nancy POWERS. Five children were born: James of Harlan; Jacob, deceased; Sarah, of Harlan; Ayres, Lyons, Kan.; Samuel, Minneapolis, Minn. The family came to Wapello county in 1856. Mrs. Blair died in 1861. In 1873 they became residents of Harlan and a year later he married Mrs. Elizabeth Lytton. They had one son, Harry E. Blair, an employee of this office. The second Mrs. Blair lived only three years after her marriage. The fruit of these marriages is 6 children, 36 grandchildren, 37 great grandchildren, 1 great, great grandchild, 5 generations.

Mr. Blair was a life-long Democrat. In the pioneer conditions under which his life was passed, so common a century ago, he got little education, but after he took up the trade of carpenter, which he followed during his active life, he taught himself to read and write and became a great student. Most of his leisure hours were spent in reading. Naturally he became well informed on all public affairs. He has been confined to his bed about a month but his general health has been failing since he suffered from the flu two years ago. Two cabinets made by Mr. Blair and his partner, Will George, nearly 40 years ago, are still a part of the Tribune office furniture.

He was a man sparing in his criticism, generous to a fault and of a quiet, mild manner that retained his same friends through his long life.

Blair and Bruce Family Connection?

The Scottish Historical Society published the Genealogical Collections of Walter McFarlane. In volume 34, pages 76, 77 and 78, the family of Leslie is described: "Andrew, First Earl of Rothes, married [1] Isobel Hamilton, daughter of Sir James Hamilton, Lord Evandale. She gave him three sons and two daughters: James, Patrick, Andrew, Margaret and Euphan; [2] Patrick was made by King James VI Commentator of the Abbacy of Lundoris, and then Lord Lundoris, Anno 1660, and from his father and the King had a sizable estate. He married Jean Stuart, d/o Patrick Earl of Orknay |son of Robert Stewart, Earl of Orknay Natural; who was son of King James VI. Jean Stewart gave Patrick five sons and five daughters: Patrick, James, Robert, Ludovick, and David [see next paragraph and daughters were not named. However, Daughter 1 married (1) George Lesley of that Ilk and (2) John Forbes. Daughter 2 married Sinclair Laird of Maii in Caithness. Daughter 3 marriedDrummond, Lord Madertie. Issue:Lord Madertie, General William Drummond, Viscount of Strathallan, Ludovick Drummond, and Margaret who married Sir Robert Crichton [alias Murry?]. Daughter 4 married Sir John Cunningham of Broomhill and Daughter 5 married Sir David Barklay of Cullairnie in Fife.

Of the five sons: Patrick, James, Robert, Ludovick, and David, Patrick succeeded his father [and] Patrick was succeeded by his younger brother, James, who was the Third Lord Lundoris. With little of any fortune left, it states he was a Groom of the Bed Chamber to King Charles 1st ? James married (1) a daughter of Ormistoun (?) and (2) a daughter of Lord Gray. Two Englishwomen were among his two last ladies. His second lady gave him a son John who succeeded him and his fourth lady gave him a daughter Jean Leslie. These are the children that interest me. They are both children of

Patrick Leslie by different ladies [wives?]. Jean married (2) Bruce, Younger of BLAIRHALL. Her brother, John Leslie, who became the Fourth Lord Lundoris married (1) Majory Ogilvie, dau. of James, Earl of Airlie. He married (2) the widow of James Elphinstoun, Lord Cowpar, who gave him at least one son named David. John married (3)Gibsone, Lady Pilton.

Does anyone have knowledge of this Bruce, Younger of Blairhall? In Bruce, The First 1,200 Years by Michael Bruce, there are two mentions of Blair. Page 18 lists a marriage of Agnes Bruce, daughter of Sir Robert Bruce [9th Baron of Clackmannon by his second marriage to Helen, daughter of Robert Durie of that Ilk]. Sir Robert Bruce was knighted by James VI in 1615, so these children were born in the early 1600's [?]. Agnes married Patrick Blair of Essie.

The other mention of Blair is on page 24. Alexander Bruce of Airth was a legitimate son of Sir Robert Bruce, 3rd Baron of Clackmannon. He died before 1487 and married twice (1) Janet, probable daughter of 1st Lord Livingston and (2) Margaraet, daughter of Sir Malcolm Forrester of Torwoodhead. By Margaret he had at least six sons and a probable daughter [Major William Bruce Armstrong, Collecteana Bruceana, pages 204-5, 352] named Agnes who married (1) Sir William Sterling of Keir and (2) Adam Blair of Adamtown. No mention of Blairhall or Bruce the Younger [?].

I would love to hear from anyone who has looked into Bruce the Younger of Blair Hall. Who was he? He is not in the Bruce genealogy. Nancy K. Schaffer, 20751 Chartwell Dr., Kildeer, IL 60047-8542; e-mail: NKSchaffer@aol.com.

Note found at Carlisle, Kentucky Historical Society by Russ Emery (BSGR Mem. #423):

I Alexander Blair of the County of Nicholas and State of Kentucky do by these presents liberate, emancipate and set at Liberty a negro Woman slave belonging to me, named Nann, about 24 years of age. Given under my hand and fiat this 23rd day of December 1805. [signed] Alexander Blair [Notary Seal]

John J. Blair, Sr., Pike County, Alabama, A Lineage Correction By Thomas William (Bill) Blair, Jr., BSGR Mem. #773

I was listed as a new member in your Summer 1997 (Vol. XV, No. 2) issue. Unfortunately there were two and likely three errors included in my lineage biography.

I did not include my ancestors' information on my application because there were still several question marks. Some of those researching our family's history have made some incorrect assumptions, which has caused great confusion and extra work on my part to get the corrections made. I prefer leaving something blank rather than listing incorrect information.

My biography in the newsletter read, "Bill desc. from John Solomon Blair and Kitsy Stephens Rhodes. John Solomon Blair was b. Newberry Dist., SC. and died in Pike Co., Al."

Error #1 is in my 4Gr-grandfather's name. His name was John J. Blair, Sr. I do not yet know what the J. stands for. I believe that the name Solomon was an assumption based on the fact that his first son was named William Solomon Blair (my 3Gr-grandfather) and that his grandson was named Solomon David Blair (my 2Gr-grandfather). In all the documents I have found on John Sr., the only time I have seen the initial S. was on a census index where the person writing the index misread "Blair, John Sr." as "Blair, John S."

Error #2 is with Kitty Ann Stephens Blair's name. In the newsletter she was listed as a Rhodes. This rumor was started by Johnnie Blair Deen in Texas. She has NO documentation to back up this claim. There was a Kitty Ann Rhodes in Pike County, Alabama, but this was a different person than our Kitty Ann Stephens. The Kitty Ann Rhodes was much younger than ours and I found a record

where she married ten years after our Kitty Ann died and three years after our John Sr. died.

Possible error #3 is that we do not know who the mother of William Solomon Blair is. Actually it is more likely that his mother was John Sr.'s first wife, Cedena Stephens. John Sr. married three Stephens women. We can document that wives #2 and #3 were sisters, but at this time we can only speculate that #1 was also a sister to #2 and #3. John Sr. married Cedena Stephens on 14 Feb. 1828 in Henry County, Alabama. In the 1830 census, William Solomon had already been born. Based on which census data is used, John Sr.'s second child (John J. Blair, Jr.) was born about two to three years after William Solomon. John Sr. continued having children at the rate of approximately one child per year. He had about 10 or 12 children. The next documentation we have on a wife was in 1841 where John Sr. was shown as married to Kitty Ann. According to family legend, Cedena was killed by a black bear and John Sr. married her sister Kitty Ann. However, we have no documentation of this legend that tells us when or where Cedena was killed and buried, or when or where he married Kitty Ann. Without this information we cannot say who was the mother to which children. I have suspected that William Solomon's mother was Cedena and Kitty Ann was the mother of his other children, but this is speculation based on the gap between child #1 and child #2.

So until I have more definite proof, my biography should read, Bill is descended from John J. Blair, Sr. and either Cedena Stephens (wife #1) or Kitty Ann Stephens (wife #2). John J. Blair, Sr. was born 15 March 1800 in Newberry District, South Carolina. and died 2 October 1881 in Pike County, Alabama.

Update on William Jackson Blair Family Data By Brenda Weeks, BSGR Mem. #768

It is, I guess, a tribute to the Blair Society that by the time my new member entry made it to the magazine some of the information in it was incorrect. I have come a long way in a relatively short time with a lot of help from the Society and its members. Here is a more accurate account of my Blair family.

William Jackson Blair was probably the son of James Blair and Mary Thompson. This is what the Blair descendants in Oakland, Illinois, the former home of William Jackson tell me. I do not know what their source of information is at this point. I do know that records from the church that they belonged to are available so that may be the source. Other circumstantial evidence also leads to that conclusion.

William J.'s family were the only Blairs in Coles County for approximately thirty years (1829-1859) and in the neighboring Edgar County were the only other Blairs for miles. Thomas Blair who married Susan Donica, along with two of his sisters, Jane Sanders and family, and Susan Donica's brother, Hiram and his wife, Thomas's sister, Mary Blair were all in Edgar County.

The cemetery record is the source of the date that William J. came to Illinois. The record states "William J. - April 17, 1859 - 41 yrs. - born in Indiana located 1829." The cemetery record for Thomas Blair states "Thomas-June 27, 1855 - 62y-born in Ohio located 1829." (Notice that this birth place differs from the census information on this family.) Both Thomas and William J. came to Illinois from Indiana. In the graveyard where both Thomas and William and their wives and children are buried is the grave of Mary Blair [Thompson] wife of James who died in 1855. The graveyard is fairly small and these Blair graves are very close to each other.

William Jackson married Sarah Jane Campbell 7 August 1878 in Coles County, Illinois, the marriage having been performed by John Shields who was the minister of the Predestinarian Baptist Church of Jesus Christ called Providence. It is this church's records that are available there in Oakland and may be the source of some of the information, I have this marriage record from several sources, one of them being Morgan Rajcevich of the Blair Society, and Iclang@advant.com who answers queries for the Coles County Web page.

The census record for William J. Blair for 1850 states: "Coles County, Illinois, Independence Pct. 102-103 Blair Jackson-31 m Ind farmer 1000

I found proof that William Jackson was both William Blair and Jackson Blair in the probate record, the file, #174, found in the court house in Charleston, Illinois has documents written to both William Blair and Jackson Blair and is titled Estate of W.J. Blair, 4/23/1853.

Mary "Polly" Griffin Blair remarried after the death of William Jackson. She married Jesse Rader in 1861. Of William Jackson's children the three daughters lived to be adults. Hester Elzina married Peter Orlando Hanner, 12 February 1872; Sarah E. married Patrick Whalen, 13 January 1873; Ruth Malinda married Charles Francis Childress, 5 January 1879. I am descended from Hester Elzina and a Jack Barron of 3200 SW 32nd Street, Topeka, Kansas is descended from Ruth Malinda.

I hope you will correct the information about William Jackson and family so that future generations will not be confused. Sorry for any misinformation that I may have given before.

From file folder titled Bannack Pioneers:

William G. Blair

Came to Bannack in 1867. He had a contract to carry the mail from Watson (the Sim Estes ranch near the mouth of Beaverhead Canyon). The trip was from Watson to Argenta and Bannack and was made daily except Sundays; horses were changed at Argenta. He moved from Bannack to Horse Prairie, where he took up land and engaged in stock raising for a number of years. After selling his ranch he moved to California for a time, coming back to Dillon where he died in 1933.

Confederate Records

Through Confederate pension records I've come across two Blairs unrelated to my immediate line. If you'd like more information about either of these, I'll be glad to share what I have from the pension records.

WILLIAM CARY BLAIR (1847-after 1903)—Enlisted in 1861 in Company "D", 30th Tennessee Regiment, organized in Nashville. Moved to Fannin Co., Texas about 1873. Worked as a preacher, teacher and public speaker.

JAMES WESLEY BLAIR (???-1912)— Married Martha L. (unknown) in 1866 in Lincoln Co., Tennessee. Served in Company "D", 41st Tennessee Infantry. Moved to Ellis Co., Texas in 1899. Maye Blair signed Martha's mortuary certificate in 1925.

McHenry County, Illinois Christenings (Sent by Nancy Knox Schaffer, BSGR Mem. # 493)

I found in Saint Patrick's Catholic Church in Hartland, McHenry County, Illinois three christenings of Morrison children, all three the children of John Morrison and Mary Ellen Blair: (1) baptized 5 August 1860 by Terrance Fitzsimmons: Ellen Morrison, born 3 July. Sponsors were John Sullivan and Bridget Dwyer; (2) baptized 24 December 1863, Rebecca Morrison, born 24 November. Sponsors: Michael Hoolihan and Margaret Walsh; (3) baptized 10 December 1865, Catherine Morrison, born 13 November 1864. Sponsors John Reycroft and Ellen McMahon.

"This morning we met with a boat from the garrison, commanded by lieutenant Blair, on his way to Arkansas." From Thomas Nuttall, Travels into the Arkansa Territory, 1821. Entry for March 19, 1819.
