(2) Silas Hilliard was a tax-defaulter in Burke County in 1793, according to a list of defaulters for that year published in an Augusta newspaper in those days. He evidently was not married at that time; and owned property which he had failed to return for taxation, hence the term "tax-defaulter".

**HODGES, WILLIAM** (p.139): (1) There was another daughter named Carolina, whose name had not been previously given Compiler by his informants. She married 1st., Nicholas J. Clark, Oct. 2, 1845; and 2nd., Thomas B. Lee, May 27, 1860. (2) The administration proceedings took place in Liberty County, not Tattnall. (3) The Compiler was informed years ago by the late Edward C. Hodges (1852-1930) of Clinch county, a son of Archibald Hodges, that his Grandmother Hodges' maiden name was Harriet Clifton, whereas Liberty County descendants say she was Rachel Clinton. The public records there bear out the fact that her name was Rachel.

**HODGES, NATHAN** (p.139): He was a son of John Hodges, R.S., and not of Joseph Hodges. The said John Hodges moved to Georgia from Lenoir Co. N. C., shortly after the Revolution, and Nathan who was born there, came to Georgia with his parents in his boyhood.

**HOLZENDORF, JOHN L. K.** (p.143): Add to the list of children: Emily, born 1824, married Wayne Swearingen of Nassau Co. Fla. She died in Clinch Co. Ga., 1908.

**HOWARD, GEORGE** (p.145): (1) Mr. E. O. Parker of Washington, D. C., has kindly supplied the Compiler with a copy of the Jacob Howard family record as found in his (Jacob's) old cipher-book. It contains a record of births in his father's family, as well as in his own family, and shows that George Howard, his father, was born June 17, 1777, son of John Howard; and that Christina Platt, his wife, was born March 16, 1776. (2) Christina, shown in Vol. IV as a daughter, is shown in the

above family record as Jacob Howard's only child by his first wife. (3) Since Mary and John H. Howard were not mentioned in their mother's will it is presumed they were dead at the time the will was made. (4) No dates of death for any of the family were shown in the old record.

**HOWELL, HENRY HARDY** (p.146): The daughter, Amanda, married Lawrence Dasher (not John J. Dasher).

**HUGHES, HENRY HANSFORD** (p.149): His wife (whose name was originally spelled "Arrena") was a member of Pleasant Primitive Baptist Church in Berrien County at her death Dec. 16, 1889. She had been received in by letter March 10, 1887, from Union Church.

**HULL, JOSEPH** (p.149): His son, John Hardee Hull, married Martha G. King, Dec. 5, 1849; she was a daughter of Stephen Clay King of Waynesville, Wayne county.

**HULL, JOSEPH** (p.149): The son, Noble A. Hull, was married in Liberty County, Jan. 24, 1860, to Miss Elenor C. Sturdevant.

**JOINER, CHARLES** (p.157): (1) He was Clerk of the Court of Ordinary of Wayne County, 1809-1810. (2) Add to the list of children, a son named Joseph Joiner, born 1813, married Susan Strickland, daughter of Richard and Susan Strickland. Joseph and family lived in Appling County where they appear in the 1850 and 1860 Censuses.

**JORDAN, ABRAHAM** (p.163): He served at a very young age in the Indian War, as 2nd Corporal under Capt. James A. Sweat, Ware County militia, Aug. 10th., to Nov. 18, 1840; also as a private in the same company, Nov. 19, 1840, to June 1st, 1841, and again Oct. 6, 1841 to Dec. 3, 1841.

**KELLY, WILLIAM** (p.164): Mrs Elizabeth Kelly, the wife of the subject, was born 1773 in North Carolina, and after her husband's death went to Columbia County, Fla., and made her home with her daughter, Mrs. McKenney, and died there after 1850.

HOWARD, JACOB

1801-1877

LONG

Jacob Howard was born in Barnwell Dist. S.C., Nov. 10, 1801, son of George Howard (Vol. IV). He was brought by his parents when he was ten years old to Liberty County (now Long) where he grew up and lived until his death. He was first married to Rebecca Moody Dec. 23, 1830. By her only one child was born, her death occurring soon after. Jacob Howard married the second time, March 11, 1834, to Martha Flowers, born Feb. 11, 1809 in Tattall County, daughter of Charles Flowers and his wife Martha Stanley Flowers. (Note: Charles Flowers, 1770-1841, was married in Darlington Dist. S.C., Feb. 1, 1796, to Martha Stanley, daughter of Shadrach Stanley, R.S., by his first wife Nancy Hall; Shadrach Stanley was granted bounty land by the State of Georgia, for his Revolutionary War services). Jacob Howard had eight children by his second wife. His nine children were:

4. David Clayton b. Mar. 10, 1839, died at home Aug. 28, 1862, while in C. S. Army.
5. John Stouten b. Aug. 27, 1841, m. Georgia Wilkinson, Mar. 27, 1872, dau. of Henry of Bulloch Co.
6. Henry Jewell b. Feb. 20, 1844, died single, Jan. 9, 1863.
7. Martha Emily b. Apr. 29, 1846, m. James O. Easterling, May 24, 1866.
8. Christopher Columbus b. Dec. 28, 1849, m. Mary Golden, Feb. 23, 1879, dau. of Oliver Golden from S. C.
9. Mary Elizabeth b. March 1, 1853, m. J. J. Barnard, Dec. 18, 1873.

Jacob Howard's home and plantation was on U.S. Highway 301 between Ludowici and Glennville, in that portion of Liberty now in Long County. He died there June 18, 1877, and his widow died Sept. 6, 1883. They were buried in the cemetery at Jones Creek Baptist Church of which church they were members.

Mr. Howard was a charter member of Altamaha Lodge, No. 227, at Johnson Station (now Ludowici) in 1857. He was the lodge's first treasurer in 1858 and held that office in the lodge several years. He died a member of the lodge.

HUNTER, HARDY E.

1834-1862

Hardy E. Hunter was born in Irwin County in 1834, son of Hunter (Vol. IV). He was married in Irwin County Sep. 28, 1854, to Catherine Jones, born in Sampson County, N. C., Mar. 31, 1835, daughter and oldest child of Samuel Jones (Vol. IV). They had the following children:

Hardy E. Hunter enlisted in the Confederate Army, March 4, 1862, Co. "E", 49th Georgia Infantry Regiment, a Wilcox County company. He was wounded in battle 1862 (date and place not shown on company roll) and while in the Chimborage Hospital, Richmond, Va., developed measles, and died of measles and his wounds Nov. 25, 1862.

Mr. Hunter and his wife were members of Bethlehem Baptist Church in Irwin (now Ben Hill) County. She was received and baptized Dec. 9, 1854, and he likewise on July 14, 1859. He remained a member until his death, but she was excluded Oct. 21, 1865.

Soon after the termination of the war, Mrs. Hunter took her children and moved to Clinch (now Lanier) County, and found employment on the farm of Wm. B. Rowan (Vol. III), and later had two illegitimate sons by Rowan, viz: John Lucian Hunter, born 1865, married Mary Sedgwick, dau. of Wm. F.; and William Henry Hunter, born 1866, married Mary Jane David, Jan. 4, 1891, daughter of John J. David. These sons grew up to be worthy citizens of Clinch County.

Mrs. Catherine Hunter died in Homerville, Oct. 19th, 1895, and was buried in the Homerville town cemetery, where also were buried her sons, M.F., J.L., and W.H. Hunter and daughter Mrs. Burwell.
