and down the coast, at that period, were few and far between, and those that did pass, gave St. Helena Sound a wide berth, and still do, so that it was not long before Colonel Glover realized that he must look elsewhere than out to sea if he was to be rescued. Numerous wide creeks and a broad expanse of marsh back of the island precluded escape in that direction. As a last resort "Colonel Glover and the most trusted slave, a powerful swimmer, swam the narrowest parts of the inlets between where they had landed and St. Phillips Point, at the mouth of Port Royal Sound", (now known as Bay Point. The inlets referred to are now known as Fripps, Skull, Pritchards and Trenchards)

"Some days later" a boat under an English flag came down the river from Beaufort near enough for Colonel Glover to signal for assistance, and the "Captain's Brig" was sent "into the inlet back of the point" where Colonel Glover and his "trusted slave" were taken aboard. The Captain of the vessel introduced himself as "Captain Charles Glover of Antigua" (one of the West Indies belonging to Great Britain) "bound for Charles Town, South Carolina."

None of the accounts referred to trace any relationship between the two. However, court records show a copy of a will, made in 1770, of "Charles Glover of Antigua", also one of Robert Glover "in the Island of Antego" (sic), in which will, made in 1700, he refers to "my son Charles Glover now in the Island of Jamacia" (sic).

(Surrogate Court, New York, N. Y. Ek 5, P 284 and Ek 2, P.41)

The balance of the crew, left on "Point Lookout Island" were, of course, rescued and Colonel Glover, including the entire crew were delivered safely at Charles Town where there was a large (for that day) sailing vessel that "pleased the fancy of Colonel Glover"

landed. Probably prompted by his recent adventure and by a long cherished desire to own "a real boat", he purchased the vessel, referred to as a "three masted square rigger' and, although he engaged the services of the Captain and his crew, Colonel Glover sailed his "three masted square rigger" home to "Hywassee". He, afterwards, often sailed his "three masted square rigger" out of the mouth of the Edisto River up the coast to Charles Town with produce and back with supplies.

Thereafter, when Colonel Glover found it expedient to spend the summers at Newport, Rhode Island, he sailed his ship from his home in South Carolina to "his summer home in Newport" in the company with those friends and relatives who made it a practice of spending their summers there; and preferred the sea voyage with Colonel Glover and his family to a journey by stage coach or other horse-drawn vehicle, which had been the means of their making such trips previous to Colonel Glover's investment in the "three masted square rigger". "Captain Glover" is referred to as master of the ship in all accounts extant, so that it is probable that the services of the original "Captain and Crew" of this "three masted square rigger" were dispensed with after the first trip to "Hywassee". Colonel Glover and his friends would leave "about May the first" and return "about November first". Among those listed as having made the trip to Rhode Island appear the names of Skirving, Haines, Logan, Postell, D'Oyley, Fenwick, Elliott, Jackson, Ashe, Webb, Hamilton, Hayne, Sanders, Roberts, Baker and Seabrook; possibly all of whom were his neighbors. He, his family, friends and neighbors, kept this up for several years possibly after he pur-
